

SENATE BILL 112

NEW LAW ALLOWING LIMITED PRESCRIBING AUTHORITY FOR MONTANA PHARMACIST IN PLACE - MPA PROVIDING PROTOCOL GUIDELINES FOR MEMBERS

Good news! The Montana Board of Pharmacy published their final administrative rules implementing Senate Bill 112 that was advanced by MPA in the 2023 legislative session. This new law, effective December 23, 2023, allows for independent prescribing authority for pharmacists in limited situations.

LEGAL HIGHLIGHTS OF SB 112:

- A MT pharmacist may prescribe a drug or device provided a patient-prescriber relationship is established through a documented patient evaluation that:
 - o Establishes a diagnosis, if the drug or device is being prescribed, and
 - o Identifies underlying conditions & contraindications to the treatment.
- Pharmacist's prescribing authority is limited to drugs and devices that:
 - o Do not require a new diagnosis.
 - o Are minor and generally self-limiting.
 - o Are diagnosed by or for which clinical decisions are made using a federally approved test.
- A pharmacist can bill only for assessment services that were necessary, based on the pharmacist's professional judgment and a pharmacist may not prescribe a controlled substance or an abortion-inducing drug as that term is defined in Montana Law 50-20-703.
- A pharmacist prescribing a drug or device pursuant to SB 112 shall:
 - o Recognize the limits of the pharmacist's knowledge & experience.
 - Maintain documentation sufficient to justify the care provided.

SB 112 does not apply to pharmacists who operate within a collaborative practice agreement.

ATTENTION PHARMACISTS: Know the 5 common coverage gaps that could cost you your career.

MONTANA BOARD OF PHARMACY UPDATES

FINAL RULE IMPLEMENTING 2023 LEGISLATION – SB 112 PHARMACIST PRESCRIBING AUTHORITY, EFFECTIVE 12/23/2023

On December 22, 2023, the Montana Board of Pharmacy published a final rule implementing 2023 legislation SB 112, that allows for independent prescribing authority for pharmacists in limited situations. This means that pharmacists can prescribe pursuant to the limitations and requirements outlined in:

- Statute: 37-7-106, MCA, Pharmacist Prescribing Authority – Exceptions, and
- Rule: ARM 24.174.505, Pharmacist Prescribing: General Requirements

The final rule, MAR 24-124-80, responds to comments received, adopts New Rule I (ARM 24.174.505) exactly as proposed, and became effective December 23, 2023.

The adopted final rule text is currently available in the proposed rule and will eventually be listed online with the other Board rules The final rule is also available in the unofficial version of the Board's rules posted online. NALOXONE STANDING ORDER 2024

On January 1, 2024, the Montana Department of Public Health and Human Services (DPHHS) issued 2024 Montana Statewide Standing Order for Naloxone Opioid Antagonist, posted on the Board of Pharmacy's webpage at www.pharmacy.mt.gov. Additional information from DPHHS opioids, overdose, naloxone

2023 LEGISLATION EXPANDING AUTHORITY FOR NATUROPATHIC PHYSICIANS AND MIDWIVES

The Board of Alternative Health Care issued a final rule, MAR 24-111-28, implementing 2023 legislation regarding amendments to prescribing authority listed below. The Board of Pharmacy is implementing new dispensing authority with no rulemaking:

- Naturopathic Physician Prescribing: SB 100 expands naturopathic physician prescribing authority, effective August 27, 2023. This legislation removed the terms "natural" and "natural substances" from the formulary list restrictions. The final rule amends the formulary list to accommodate the authority for all legend drugs and other items, except for those drugs listed in rule. For additional details, see ARM 24.111.511, Naturopathic Physician Formulary List.
- Midwives: HB 392 creates an endorsement for midwives authorizing them to obtain and administer an expanded list of drugs, effective October 1, 2023. This rule includes the purchase of certain drugs from wholesale drug distributors and pharmacies licensed by the Board of Pharmacy. This authority does not impact certified nurse midwives licensed by the Board of Nursing. See rules ARM 24.111.614 – 616, for additional details on educational requirements; obtaining, storing, and disposing of drugs; and use of formulary drugs.
- Naturopathic Physician Dispensing: the 2023 Legislature also passed SB 101, authorizing naturopathic physicians to dispense medications directly to their own patients using a Medical Practitioner Dispenser registration issued by the Board of Pharmacy. This legislation adds naturopathic physicians, pursuant to their formulary list, to the dispensing requirements and restrictions in place for medical practitioners.  - o 37-2-104(1-9), MCA, Prescribing and Dispensing of Drugs
 - ARM 24.174.1801 through 1803, Medical Practitioner Dispensing

MONTANA PRESCRIPTION DRUG REGISTRY (MPDR) UPDATES

The MPDR is Montana's prescription monitoring program where authorized healthcare providers can view controlled substance prescriptions dispensed to patients by Montana licensed pharmacies to improve patient safety. The MPDR uses **PMP AWARxE** for searching patient medication reports, **PMP Clearinghouse** for prescription data submission, and **PMP Gateway** for MPDR integration with health information systems (HIS).

PMP AWARxE contains clinical tools to help evaluate a patient medication report, including NarxCare scores and graphs. The display and content of these scores and graphs will be updated on December 6, 2023. Please visit MPDR NarxCare Fact Sheet for details on this new version of NarxCare. Also, a new "Notice" feature in PMP AWARxE has been enabled to allow for secure one-way messaging from a PMP AWARxE user to the MPDR administrator. Use this "Notice" to message the administrator quickly and securely with any concerns such as patient matching issues or missing information. To access this feature while logged into the MPDR, navigate to Menu, then Notices, and select New Notice.

Through a continued collaboration with the Montana Department of Public Health and Human Services (DPHHS), we are excited to announce that PMP Gateway fees will remain covered for Montana healthcare facilities and pharmacies at least through August 2028. More than 200 facilities and pharmacies have taken advantage of one-click access to MPDR information. 

LAW ENFORCEMENT ACCESS TO PROTECTED HEALTH INFORMATION – WHAT'S YOUR POLICY?

Understanding and adhering to the HIPAA Privacy Rule is required for covered entities who handle protected health information (PHI), but because the Privacy Rule was designed to be flexible, implementation of policies and procedures to meet the Privacy Rules can vary from covered entity to covered entity. Look no further than the December 12, 2023 letter1 from the United States Senate Committee on Finance (herein, "The Committee") for evidence of this variation and how it can seriously impact the privacy of sensitive patient data.

In the December letter drafted to Xavier Becerra, Secretary of the U.S. Department of Health & Human Services, The Committee outlined the results of their oversight inquiry into the seven largest pharmacy chains (CVS Health, Walgreens Boots Alliance, Cigna, Optum Rx, Walmart Stores, Inc., The Kroger Company, and Rite Aid Corporation), and Amazon Pharmacy. The inquiry focused on obtaining briefings from the major pharmacy chains about their policies and procedures for releasing PHI to law enforcement agencies. Below is a general overview of the findings:

- Five pharmacy corporations had policies that would require a law enforcement agency's demand for PHI to be reviewed by legal professionals before responding.
- The remaining three pharmacy corporations had policies that put "extreme pressure" on the pharmacy staff to respond to the inquiries immediately and stated their pharmacy staff "are trained to respond to such requests and can contact the legal department if they have questions."
- None of the pharmacy corporations required warrants to share information with law enforcement agencies, unless required by state law.
- Pharmacies would turn over PHI to a law enforcement agency when presented with a subpoena ("which often do not have to be reviewed or signed by a judge prior to being issued")
- Only CVS Health published annual transparency reports on the records requests from law enforcement.

 Patients already have the right to know who is accessing their health information through the HIPAA Accounting of Disclosure process, but the obligation is on the patient or their authorized representative to request the appropriate information from the covered entity; since this patient right is not well known in the general patient population it leads to a very small number of disclosure requests annually

The Committee urged the Secretary to strengthen HIPAA Privacy regulations to better protect PHI, and referenced a 2010 decision2 from the Federal Court of Appeals which protected the privacy of emails and would require a warrant before providers such as Google, Yahoo, and Microsoft could release customer data.

What does this mean for independent pharmacies? As stated in The Committee's letter, "These findings underscore that not only are there real differences in how pharmacies approach patient privacy at the

pharmacy counter, but these differences are not visible to the American people." Also, "Proactively notifying customers about any patient record disclosures to law enforcement that impact their medical records, except where prohibited by a non-disclosure or "gag" order issued by a judge, would be a major step forward in patient transparency."
